VI. Staff Reports

- a. Jill Rinkel -
 - 1. 6th Grade Chorus- Concert this Thursday at 7:45 p.m. We are singing Alexanders Ragtime Band (Irving Berlin), I Am A Small Part of the World, Folk Song Handjive and In Flanders Fields. Emma Vallee and Griffin Megeff are playing the piano, Alivia Hay is accompanying on her flute, 8 students are singing in 2 solo groups, and 6 students are narrators to introduce each piece.
 - 2. 7th & 8th Grade Chorus will combine to sing a medley of songs from 'Grease' for their 'POPS' concert on Thursday, May 20th. This medley features lots of 8th graders singing solos, and everyone singing with choreography. They will perform 'Grease' for the Lincoln Trail 5th Graders on May 25th to encourage participation in 6th Grade Chorus.
 - 3. 8th Grade National Anthem singers will sing for 8th Grade Promotion on Friday, May 28th at 5:00 p.m. Recently, a small group of them sang for 2 HS soccer games.

- 2. Voice Recital Tuesday, May 26 at 7pm in the high school chorus room. Each year we hold a voice recital for any of our voice students who are studying privately to give them the opportunity to showcase their studies by performing a piece they have been working on. We are excited that nearly 50 students elected to study privately during the course of this school year.
- 3. **Summer Schedule**: Summer lessons will be scheduled on Monday and Tuesday from 10-5. Lesson prices are \$14.00 per half hour. Lessons will begin until June 7th and will continue through the summer. I am currently in the process of seeing who is available to teach over the summer. Information will be posted on the music website.
- 4. **2010 Madrigals**: will begin rehearsing on June 3rd from 11-3.
- 5. **District folders:** will be available for "purchase" of \$22 beginning on May 26th. Students can get a jump on learning the audition music for the District/All-State audition on October 11th.
- 6. **Lincoln Trail Music Position:** We will be interviewing candidates for the LT music job, which includes 3rd and 4th grade general music and 5th grade chorus this Friday. We have many well-qualified candidates.
- 7. Presentation to the School Board Last Monday evening, all the M-S District Fine Arts' staff in Drama, Visual Art and Music presented information to the School Board about what it is we do in the Fine Arts. We used the format of a PowerPoint, with videos and pictures to share our passion for teaching in the Fine Arts with the Board members. They were very complimentary, interested, receptive, and appreciative in what we do in our classrooms on a daily basis. With recent budget cuts, the district Fine Arts staff appreciated the opportunity to inform the Board about our programs.
- 8. **Next year's Chorus/Drama trip** to Chicago to see a Broadway show will be on Wed., Nov. 17 to see The Lion King.
- 9. **Mark Hayes:** I am working on getting Mark Hayes, a famous choral composer and arranger (who arranged the piece <u>Swingin' with the Saints</u> that we sang as a combined piece to close the February concert) to come to Mahomet to work with our students. He is a family friend of Fran Street and contacted him. We have a tentative date set for Thursday and Friday, March 3-4. Jill and I are thinking about including the 7/8 grade combined choirs, in addition to the combined high school choirs in a one-day "festival" style
